The appointment shall be on contract basis initially for a period of one year from the date of joining the post, but contract can be reviewed thereafter on yearly basis which will stand terminated automatically at the end of contractual period without any notice.

1. The Horticulture Extension Officer appointed on contract basis will be paid consolidated monthly emoluments equivalent to the minimum of the Pay band of Rs. 5910-20200+2400 Grade Pay +125% Grade Pay (Rs. 5910+2400 (G.P)+3000/-). He/ She shall not be entitled for any other allowance whatsoever is admissible to the employees of State Government from time to time.
2. His/ Her age at the time of joining the post should neither be less than 18 years nor more than 45 years. It is relaxable by five years in case of Schedule Caste/ Schedule Tribe Classes.
3. His/ Her appointment shall be subject to the production of Medical Certificate of fitness from the Distt. Medical Officer of the Govt. Hospital.
4. **He/ She is liable to serve anywhere in Himachal Pradesh**

5. Contractual appointment shall not confer any right to the incumbent for regularization of service at any stage.
6. Contractual Horticulture Extension Officer will be entitled for one-day casual leave after completing one-month service. However, the contract employee will also be entitled for 180 days maternity leave, 10 days medical leave and 5 days special leave. He/ She will not be entitled for Medical Reimbursement and L.T.C. etc. No leave of any other kind except above is admissible to them. Provided that the un-availed Casual Leave, Medical Leave and Special Leave can be accumulated up to the calendar year and will not be carried forward for the next calendar year.
7. Unauthorized absence from the service without the approval of the Head of the Office shall automatically lead to the termination of the contract. Contractual Horticulture Extension Officers will not be entitled for any contractual amount for the period of absence from duty.
8. Contractual Horticulture Extension Officers who will have completed three years tenure at one place of posting will be eligible for transfer. The transfer on administrative grounds, where ever required, will be made on need based basis and against vacant or contract employee only.
9. After selection of a candidate, he/she has to sign an agreement as per annexure-“A” appended to these rules.
10. Contractual Horticulture Extension Officers shall be entitled for TA/DA if required to go on tour in connection with official duties at the same rate as applicable to regular employees.
11. No TA/DA will be admissible for joining this assignment.
12. He is required to produce antecedent's verification certificate to the satisfaction of the department from the First Class Magistrate or the Gazetted Officers known to him/her at least for last five years.
13. If above terms and conditions are acceptable to the concerned Horticulture Extension Officer, they may join their duty within 15 days from the issuance of these orders failing which the appointment offer shall automatically stand cancelled.

ANNEXURE-'A'

AGREEMENT

Form of contract/agreement to be executed between the Horticulture Extension Officer and the Government of Himachal Pradesh through Director of Horticulture Himachal Pradesh

This agreement is made on this _____ in the year _____
Between _____ Village _____, P/O _____,
Tehsil _____, District _____, H.P. Contract appointee
(hereinafter called the FIRST PARTY), and The Government of Himachal Pradesh
through the Director of Horticulture, H.P. (here-in-after called the SECOND
PARTY).

Whereas, the SECOND PARTY has engaged the aforesaid FIRST PARTY and the FIRST PARTY has agreed to serve as **Horticulture Extension Officer** on contract basis on the following terms & conditions:-

1. That the FIRST PARTY shall remain in the service of the SECOND PARTY as **Horticulture Extension Officer** for a period of one year commencing on day of _____ and ending on the day of _____. It is specifically mentioned and agreed upon by both the parties that the contract of the FIRST PARTY with SECOND PARTY shall ipso-facto stand terminated on the last working day i.e. on _____. And information notice shall not be necessary.

Provided that for – further extension/renewal of contract period the HOD shall issue a certificate that the service and conduct of the contract appointee was satisfactory during the year and only then the period of contract is to be renewed/extended.

2. The contractual amount of the FIRST PARTY will be Rs. P.M. & 3% minimum of Pay band + G.P. of the post as annual increase in contractual emoluments for the subsequent years will be allowed if contract is extended beyond one year.
3. The service of FIRST PARTY will be purely on temporary basis. The appointment is liable to be terminated in case the performance/conduct of the contract appointee is not found good or if a regular incumbent is appointed/posted against the vacancy for which the first party was engaged on contract.
4. Contractual _____ (Name of the post) will be entitled for one day casual leave after putting in one month service. This leave can be accumulated up to one year. However contractual employee will also be entitled for 10 days medical leave and 5 days special leave. He/She will not be entitled for

Medical Reimbursement and LTC etc. Only maternity leave will be given as per Rules.

Unauthorized absence from the duty without the approval of the controlling Officer shall automatically lead to the termination of the contract. A contractual _____ (Name of the post) will not be entitled for contractual amount for the period of absence from duty.

6. An official appointed on contract basis who have completed three years tenure at once place of posting will be eligible for transfer on need based basis wherever required on administrative grounds.
7. Selected candidate will have to submit a certificate of his/her fitness from a Government/Registered Medical Practitioner. In case of women candidates pregnant beyond twelve weeks will render her temporarily unfit till the confinement is over. The women candidate should be re-examined for fitness from an authorized Medical Officer/Practitioner.
8. Contract appointee shall be entitled to TA/DA if required to go on tour in connection with his/her official duties at the same rate as applicable to regular counter part official at the minimum of pay scale.
9. The Employees Group Insurance Scheme as well as EPF/CPF will not be applicable to contractual appointee(s). IN WITNESS the FIRST PARTY AND SECOND PARTY have herein to set their hands the day, month and year first above written.
