NOTIFICATION

In exercise of the powers conferred by proviso to Article 309 of the Constitution of India, the Governor, Himachal Pradesh in consultation with the H.P. Public Service Commission is pleased to make the following rules further to amend the Himachal Pradesh Horticultural Services Class-I, (Gazetted) Recruitment & Promotion Rules, 2007 notified vide Notification No. Udyan-Kha(7)-8/92-II, dated 18-8-2007, namely :-

Short title and commencement 1.(1) These rules may be called the Himachal Pradesh Horticultural Services Class-I,(Gazetted) Recruitment & Promotion (First Amendment)Rules,2011.

(2) These rules shall come into force from the date of its publication in the Rajpatra, Himachal Pradesh.

Amendment of Annexure "A" 2.

In Annexure "A" to the Himachal Pradesh Horticultural Services Class-I, (Gazetted) Recruitment & Promotion Rules,2007, for the existing entries against column No.18 the following shall be substituted, namely :-

"After the notification of these rules and consequent upon the formation of H.P.Horticulture Services Class-I (Gazetted) from the date of issue of this notification, a combined seniority list not disturbing the seniority as on 1.1.1991, shall be determined in the following manner.

(i) The incumbents of the post of Deputy Director (Hort./Project Co-ordinator/ Sr. Subject Matter Specialist (Hort./Sr. Subject Matter Specialist (Floriculture)/Deputy Director of Horticulture(Information/ Senior Plant Protection Officer/ Sr. Subject Matter Specialist(PP)/ Sr. Marketing Officer/ Sr. Analytical Officer/ Fruit Technologist those who were appointed/ promoted prior to the date of revision of pay scales i.e. 1.1.1991 maintaining their seniority as such, shall be placed

enblock senior to the class-II Officers now forming the common cadre;

(ii) Thereafter, in this order below the above officers, incumbents of the post in class-II Gazetted, which includes Horticulture Development Officer/ District Horticulture Officers/ Assistant Project Officers/ Mushroom Development Officer/ Subject Matter Specialist/ Assistant Floriculturist/ Quality Control Officer/ Procurement & Sales Officer/ Assistant Fruit Technologist/ Food Microbiologist/ Nursery Inspection & Certification Officer(Entomology)/Bee-Keeping Development Officer/ Subject Matter Specialist(Hort.)/ Assistant Marketing Officer(Hort.)/ Plant Protection Officer/ Assistant Post Harvest Physiologist/ Assistant Analytical Officer/ maintaining their present group wise seniority prior to the date of revision of pay scales i.e. 1.1.1991 shall be placed enblock senior to the Horticulture Development Officer.

(iii) Thereafter, the incumbents of the post of Horticulture Development Officers, Manager-cum-Chemist, Fruit Preservation Assistant/Quality Control Inspector, Senior Technical Assistant(Fruit Technology), Senior Technical Assistant (Food Microbiology), Senior Chemical Assistant & Research Assistant in the order of their present seniority as on 1.1.1991 shall be at the bottom i.e. immediately below the above class-II officers.

IN THE MATTER OF POSTING, THE SENIOR MOST INCUMBENTS SHALL BE POSTED AGAINST THE POST OF DEPUTY DIRECTOR OF HORTICULTURE/SENIOR SUBJECT MATTER SPECIALIST (HORT.)/ SENIOR SUBJECT MATTER SPECIALIST (PP) PROJECT COORDINATOR / SENIOR MARKETING OFFICER/ SENIOR ANALYTICAL OFFICER/ FRUIT TECHNOLOGIST FOLLOWED BY THE NEXT SENIOR BEING POSTED AS DISTRICT HORTICULTURE OFFICER ETC. AND SO ON PROVIDED THEY ACQUIRE REQUISITE PROFESSIONAL QUALIFICATION PRESCRIBED IN COL. NO. 7 AND 11.

Provided that the above clause of acquiring of requisite professional qualification prescribed in COL 7 and 11 shall not be applicable to those officers of common cadre of H.P.Horticulture Services Class (Gazetted) who are / were the members of Horticulture Service Class-I (Gazetted) as on the date of issue of notification of R & P Rules of H.P.
